



LOCATION CHANGE FOR THE 2015-2016 SBE BOARD MEETING CALENDAR

The Board approved the 2015-2016 SBE Meeting Dates and Locations at the November meeting. The July 8-9, 2015 meeting was approved by the Board to be held in Federal Way. The Federal Way Public School District Office is the most appropriate facility for this area. After inquiring with the district about meeting space, it was discovered that the district office would not be an ideal location during the summer months for the following reasons:

- There would be a shortage of district support staff;
- Administrators and teachers attend their orientation sessions at the district office using the large meeting rooms;
- Custodians typically begin their large facility projects and maintenance, which will most likely be a noisy distraction; and
- If available, the meeting room could not be reserved for the SBE meeting until January 2015 at the earliest.

Recommendation

The Executive Committee is recommending the location for the July 8-9, 2015 board meeting to be changed to the Seattle area. Staff are proposing the South Seattle Community College in Georgetown.

Action

Approve recommended location change for the July 8-9, 2015 meeting.

Summary of Draft Emergency Rules WAC 180-17-020 Process for submittal and approval of required action plan.

Timeline for submittal and approval of required action plans for 2014 only.

As discussed in the Required Action Plan Approval Process section of this Board packet, emergency rules are necessary for this year only, since identification of required action districts was late due to the submission of the revised Achievement Index and identified priority and focus schools to the federal Department of Education for approval of Washington’s ESEA (Elementary and Secondary Education Act) waiver application.

School district shall submit a required action plan for approval by OSPI.	May 23, 2014
School district shall submit a required action plan approved by OSPI to SBE.	May 28, 2014
SBE shall either approve of the school district’s required action plan or notify the school district of disapproval stating the reasons for disapproval.	June 10, 2014

If the required action plan is not approved by SBE, the district shall either:

Submit a new plan to OSPI and SBE.	July 3, 2014
------------------------------------	--------------

or:

Request a review of the plan by the required action plan review panel.	June 20, 2014
The review panel shall consider and issue a decision regarding the district’s request for reconsideration to the SBE.	July 10, 2014

If SBE accepts the changes to the required action plan recommended by the panel:

The school district shall submit a revised required action plan to OSPI and SBE.	July 30, 2014
SBE shall approve the plan if it incorporates the recommended changes of the panel.	August 10, 2014

If the review panel issues a decision that reaffirms the decision of SBE rejecting the school district’s required action plan:

The school district shall submit a revised plan to OSPI and SBE.	Within twenty days of the panel’s decision
SBE shall approve the district’s required action plan if it meets all of the requirements set forth in RCW 28A.657.050.	August 10, 2014

WAC 180-17-020 Process for submittal and approval of required action plan.

(1) Except as otherwise provided in WAC 180-17-030, and in subsection (5) of this section, school districts designated as required action districts by the state board of education shall develop a required action plan according to the following schedule:

(a) By April 15th of the year in which the district is designated, a school district shall submit a required action plan to the superintendent of public instruction to review and approve that the plan is consistent with federal guidelines for the receipt of a School Improvement Grant. The required action plan must comply with all of the requirements set forth in RCW 28A.657.050.

(b) By May 1st of the year in which the district is designated, a school district shall submit a required action plan approved by the superintendent of public instruction to the state board of education for approval.

(2) The state board of education shall, by May 15th of each year, either:

(a) Approve the school district's required action plan; or

(b) Notify the school district that the required action plan has not been approved stating the reasons for the disapproval.

(3) A school district notified by the state board of education that its required action plan has not been approved under subsection (2) (a) of this section shall either:

(a) Submit a new required action plan to the superintendent of public instruction and state board of education for review and approval within forty days of notification that its plan was rejected. The state board of education shall approve the school district's required action plan by no later than July 15th if it meets all of the requirements set forth in RCW 28A.657.050; or

(b) Submit a request to the required action plan review panel established under RCW 28A.657.070 for reconsideration of the state board's rejection within ten days of the notification that the plan was rejected. The review panel shall consider and issue a decision regarding a district's request for reconsideration to the state board of education by no later than June 10th. The state board of education shall consider the recommendations of the panel and issue a decision in writing to the school district and the panel by no later than June 20th. If the state board of education accepts the changes to the required action plan recommended by the panel, the school district shall submit a revised required action plan to the superintendent of public instruction and state board of education by July 30th. The state board of education shall approve the plan by no later than August 10th if it incorporates the recommended changes of the panel.

(4) If the review panel issues a decision that reaffirms the decision of the state board of education rejecting the school district's required action plan, then the school district shall submit a revised plan to the superintendent of public instruction and state board of education within twenty days of the panel's decision. The state board of education shall approve the district's required action

plan by no later than July 15th if it meets all of the requirements set forth in RCW 28A.657.050.

(5) For required action districts designated in 2014 only, the schedule for plan submittal and approval of required action plans will be as follows:

(a) A school district shall submit a required action plan for approval by the office of the superintendent of public instruction by May 23, 2015.

(b) A school district shall submit a required action plan approved by the office of the superintendent of public instruction to the state board of education for approval by May 28, 2014.

(c) The state board of education shall, by June 10, 2014 either approve the school district's required action plan or notify the district that the required action plan has not been approved stating the reasons for the disapproval. The district shall either:

(i) Submit a new plan to the office of the superintendent of public instruction and the state board of education by July 3, 2014.

(ii) Request a review of the plan by the required action plan review panel by June 20, 2014. The review panel shall consider and issue a decision regarding the district's request for reconsideration to the state board of education no later than July 10, 2014. If the state board of education accepts the changes to the required action plan recommended by the panel, the school district shall submit a revised required action plan to the superintendent of public instruction and the state board of education by July 30, 2014. The state board of education shall approve the plan no later than August 10, 2014, if it

incorporates the recommended changes of the panel. If the review panel issues a decision that reaffirms the decision of the state board of education rejecting the school district's required action plan, then the school district shall submit a revised plan to the superintendent of public instruction and state board of education within twenty days of the panel's decision. The state board of education shall approve the district's required action plan by no later than August 10, 2014, if it meets all of the requirements set forth in RCW 28A.657.050.
