Review of RAD Designation

- **2011:** 4 districts designated for RAD Cohort I, effective 2011-12
- Soap Lake SD Designation: Identification based on persistently low and declining performance of *Soap Lake MS & HS* on state assessments
- 2014:
 - Identified school in each RAD Cohort I district exited Priority status, effective 2014-15
 - Three of four districts exited RAD status, effective 2014-15
 - Soap Lake SD remained in status due to identification of Soap Lake ES as a Priority school in spring 2014, effective 2014-15

Soap Lake Middle & High School: Performance on State Assessments



- **2011** Declining performance over 3 years led to district's designation for required action
- 2012 Middle & High School designated as a Priority school
- **2014** School met criteria to exit Priority status, effective 2014-15
- 2016 and 2017 2-Year Averages in ELA/Math on SBAs
 - All Students: 31.54% (Threshold = 22.65%)
 - Subgroups: Hispanic 24%, Former ELL 40%, Low Income 29% (Threshold = 11.79%)



Soap Lake Elementary School: Performance on State Assessments




- 2014 Low performance over 3 years led to the following:
 - District's continued designation for required action and
 - School's designation as Priority school
- 2016 and 2017 2-Year Averages in ELA/Math on SBAs
 - All Students: 34.93% (Threshold = 22.65%)
 - Subgroups: Hispanic 20.21%, Former ELL 50.66%, Low
 Income 34.04% (Threshold = 11.79%)





Soap Lake Elementary School: Performance on SB Assessments, 2015 and 2016



	2015	2016	Change
ELA	30.77%	39.22%	8.45%
Math	28.57%	41.18%	12.61%

Requirements to Release from RAD Status



- District implemented required action plan for 3 years;
- District has made progress, as defined by superintendent of public instruction using criteria adopted under RCW <u>28A.657.020</u> including progress in closing the educational opportunity gap; and
- District no longer has a school within the district identified as persistently lowest-achieving.

(From RCW 28A.657.100)

Summary: Soap Lake School District



- District met 2 of 3 requirements for release from required action
 - District implemented required action plan for at least 3 years
 - Schools show positive trajectory of improvement on state assessments and are closing educational opportunity gaps
- District not eligible for release because Soap Lake ES remains on Priority list
- OSSS will continue to work with both the district and school as long as designations continue
