## Waivers from Credit-Based Graduation Requirements

- Selah, Soap Lake, and Tonasket School Districts are applying for waivers from credit-based graduation requirements.
- Each district has worked with the Big Picture Learning network and modeled their program around the Big Picture competencies.
- We anticipate that at least two additional districts will be applying for this waiver for consideration at the July Board meeting.

## Approval of Temporary Waivers from Graduation Requirements

- Applicants at this Board meeting requested implementation for the Class of 2021 and consist of the following colleges:
  - Centralia College
  - Columbia Basin College
  - Grays Harbor College
  - Seattle Colleges District
- WAC 180-51-015 allows graduation requirements and flexibilities to apply to community colleges, community college districts, and private schools.
- This allows the colleges to align to their feeder districts even though the colleges are able to offer the 24-credit requirements.
- More colleges are expected in upcoming Board meetings, likely many in July.

## Private Schools



- “The legislature hereby recognizes that private schools should be subject only to those minimum state controls necessary to insure the health and safety of all the students in the state and to insure a sufficient basic education to meet usual graduation requirements.” (RCW 28A.195.010).
- In 2018-19 the Board approved 532 private schools, serving over 84,000 students.


### Change in Total Enrollment in Private Schools from 2017-18 to 2018-19 School Year



### Minimum private school requirements include:

- 180 school days or 1,000 instructional hours
- All classroom teachers hold WA state certifications unless they are teachers of religious courses or hold certain qualifications and are supervised by a WA state certificated teacher
- Physical facilities of the school are adequate to meet the school's program and meet "reasonable health and fire safety requirements."

## Annual Private School Approval

- SBE staff have reviewed private school applications received by April 25<sup>th</sup> for meeting minimum requirements, and are recommending approximately 460 schools for approval at the May Board meeting.
- Additional schools may be considered for approval at the July Board meeting.
- The SBE may approve schools for one year. If the Board has concerns about an applicant they may also provisionally approve schools for up to one year or withhold approval.

## STUDENT TRANSITIONS & DIPLOMA



**E2SHB 1599 - Modifies high school graduation requirements.**

**Major provisions of the bill:**

1. All elements of SBE’s request legislation:
  - Automatically grants HS credit for HS course taken in MS
  - Extends expedited (assessment) appeal
  - Changes basis for two-credit waiver from “unusual” to “student” circumstances.
  - SBE workgroup to develop *competency-based learning* diploma framework (language changed to *mastery-based learning*)

## STUDENT TRANSITIONS & DIPLOMA



### Major Provisions of 1599 (continued)

2. Discontinues CAA (2020) and CIA (2022)
3. Moves prohibition on waiving core credits from WAC to RCW
4. Adds requirements to HSBP
5. Converts assessment and assessment alternative requirements to *multiple pathways*, requiring each student to meet one (five of seven pathways were assessments or alternatives; two previous alternatives are removed).

## STUDENT TRANSITIONS & DIPLOMA



### Implications of 1599 for SBE Rule-Making:

- Must adopt WACs for Section 201 of the bill (*multiple pathways*)
- Likely amend graduation requirements WAC (180-51)
- May need to amend other WACs based on analysis of potential impacts (on WACs) regarding accountability, private schools, etc.

### Legislation's assignments to SBE re Section 201 (*multiple pathways*):

1. Survey interested parties regarding potential additional pathways or modifications to existing pathways (staff envision quantitative & qualitative survey methods).
2. Report to the education committees of the legislature by August 1, 2020, summarizing the information collected in the surveys.
3. Survey a sampling of the school districts unable to provide all of the graduation pathways under section 201 in order to identify the types of implementation barriers districts have.

### Legislation's assignments to SBE re Section 201 (*multiple pathways*):

4. Report to the education committees of the legislature by December 10, 2022, on the following:
  - a) Recommended changes to the existing pathways;
  - b) Barriers school districts have to offering all of the graduation pathways and recommendations for ways to eliminate or reduce those barriers for school districts;
  - c) Whether all students have equitable access to all of the graduation pathways and, if not, recommendations for reducing the barriers students may have to accessing all of the graduation pathways; and
  - d) Whether additional graduation pathways should be included and recommendations for what those pathways should be.

### Mastery-Learning Workgroup

**Focus:** barriers to mastery-based learning in Washington state

The workgroup shall examine opportunities to increase student access to relevant and robust mastery-based academic pathways aligned to personal career goals and postsecondary education, specifically

- Expansion of mastery-based credits to meet graduation requirements;
- Development of mastery-based pathways to the earning of a HS diploma;
- Role of HSBP in supporting mastery-based learning;
- SBE and OSPI must develop enrollment reporting guidelines to support schools operating with competency-based waivers (issued under RCW 28A.230.090).

SBE's mastery-learning workgroup responsibilities:

- Convene (by 8/1/19) and provide staff support to the work group;
- Coordinate work group membership to ensure member diversity, including racial, ethnic, gender, geographic, community size, and expertise diversity; and
- Submit an interim report (12/1/19) outlining preliminary findings and potential recommendations to the governor and the education committees and a final report (12/1/20) detailing all findings and recommendations related to the work group's purpose and tasks.

## MEMO ON WAIVERS OF THE CAREER- AND COLLEGE-READY GRADUATION REQUIREMENTS

Prepared for the May 2019 Board Meeting

### Policy Considerations

Does the application for waiver of the career- and college-ready graduation requirements provide the information and documentation required by law?

### Overview of Waivers

- Temporary waiver from Career- and College-Ready graduation requirements for the Class of 2019 and the Class of 2020, thereby requiring implementation for the Class of 2021.
  1. Centralia College
  2. Columbia Basin College
  3. Grays Harbor College
  4. Seattle Colleges College District

### Temporary Waiver from Career- and College-Ready Graduation Requirements

Does the application by Green River College for temporary waiver of Career- and College-Ready graduation requirements provide the information and documentation required by WAC 180-51-068(11)?

RCW 28A.230.090(1)(d)(ii) authorizes school districts to apply to the State Board of Education for a temporary waiver from the Career- and College-Ready graduation requirements directed by Chapter 217, Laws of 2014 (E2SSB 6552) and adopted into rule in WAC 180-51-068, to delay implementation until the graduating class of 2020 or 2021 instead of the graduating class of 2019. Furthermore, WAC 180-51-015 states that references to school districts within Chapter 180-51 WAC shall also apply to community colleges and private schools. If a waiver of WAC 180-51-068 is approved then WAC 180-51-067 applies.

Each of the aforementioned colleges or college district requests a temporary waiver from Career- and College-Ready graduation requirements for the Class of 2019 and 2020. This would result in implementation of the 24-credit graduation requirements for the Class of 2021. While the colleges are able to provide the required coursework to implement the 24-credit graduation requirements by 2019, each college serves a local student population that includes school district partners that have already been granted the waiver to delay implementation of the Career- and College-Ready graduation requirements. Each college has found that this waiver would allow them to better serve their students by aligning with district requirements. Each college submitted the required documentation, including a resolution from the college's Board of Trustees.

*Please note the applications are posted with the Board materials, however, in some cases they were not fully accessible so certain elements were removed from the posted documents and replaced with a page noting that the materials are on-file with the SBE and available upon request. In general, this would include signed copies of local Board resolutions and other documents or portions of documents that do not meet ADA accessibility requirements.*

#### **Action**

The Board will consider whether to approve the requests for temporary waiver of Career- and College-Ready graduation requirements presented in the applications of Centralia College, Columbia Basin College, Grays Harbor College, and Seattle Colleges District.

## **APPLICATION** **Temporary Waiver from High School Graduation Requirements** **Under Chapter 217, Laws of 2014**

### **Instructions**

RCW 28A.230.090(1)(e)(ii) authorizes school districts, private schools, and community colleges to apply to the State Board of Education (SBE) for a temporary waiver from the career and college ready graduation requirements directed by Chapter 217, Laws of 2104 (E2SSB 6552) beginning with the graduating class of 2020 or 2021 instead of the graduating class of 2019. This law further provides:

“In the application, a school district must describe why the waiver is being requested, the specific impediments preventing timely implementation, and efforts that will be taken to achieve implementation with the graduating class proposed under the waiver. The state board of education shall grant a waiver under this subsection (1)(d) to an applying school district at the next subsequent meeting of the board after receiving an application.”

The SBE has adopted rules to implement this provision as WAC 180-51-068(11). The rules provide that the SBE must post an application form on its public web site for use by school districts. The rules further provide:

- The application must be accompanied by a resolution adopted by the district’s board of directors requesting the waiver. The resolution must, at a minimum:
  1. State the entering freshman class or classes for whom the waiver is requested;
  2. Be signed by the chair or president of the board of directors and the superintendent.
- A district implementing a waiver granted by the SBE under this law will continue to be subject to the prior high school graduation requirements as specified in WAC 180-51-067 during the school year or years for which the waiver has been granted.
- A district granted a waiver under this law that elects to implement the career and college ready graduation requirements in WAC 180-51-068 during the period for which the waiver is granted shall provide notification of that decision to the SBE.



## Columbia Basin College Resolution No. 19-03

WHEREAS, the Board of Trustees of Community College District No. 19, Columbia Basin College, recognizes the critical role Columbia Basin College plays in partnering with local school districts in Benton and Franklin counties for the purpose of serving the educational needs of these communities, AND

WHEREAS, the legislature passed E2SSB 6552 (Chapter 217, Laws of 2104), which raises the number of credits required for graduation to 24 credits beginning with the Class of 2019, AND

WHEREAS, Columbia Basin College provides instruction to local students, including those of our district partners, AND

WHEREAS, Columbia Basin College developed high school level courses meeting the Office of Superintendent of Public Instruction curriculum standards to fulfill all credit requirements for the 24 credit high school diploma, AND

### Temporary Waiver from High School Graduation Requirements Under Chapter 217, Laws of 2014

#### Instructions

RCW 28A.230.090(1) authorizes school districts, private schools, and community colleges to apply to the State Board of Education (SBE) for a temporary waiver from the career and college ready graduation requirements directed by Chapter 217, Laws of 2104 (E2SSB 6552) beginning with the graduating class of 2020 or 2021 instead of the graduating class of 2019. This law further provides:

"In the application, a school district must describe why the waiver is being requested, the specific impediments preventing timely implementation, and efforts that will be taken to achieve implementation with the graduating class proposed under the waiver. The state board of education shall grant a waiver under this subsection (l)(d) to an applying school district at the next subsequent meeting of the board after receiving an application."

The SBE has adopted rules to implement this provision as WAC 180-51-068(11). The rules provide that the SBE must post an application form on its public web site for use by school districts. The rules further provide:

- The application must be accompanied by a resolution adopted by the district's board of directors requesting the waiver. The resolution must, at a minimum:
  1. State the entering freshman class or classes for whom the waiver is requested;
  2. Be signed by the chair or president of the board of directors and the superintendent.
- A district implementing a waiver granted by the SBE under this law will continue to be subject to the prior high school graduation requirements as specified in WAC 180-51-067 during the school year or years for which the waiver has been granted.
- A district granted a waiver under this law that elects to implement the career and college ready graduation requirements in WAC 180-51-068 during the period for which the waiver is granted shall provide notification of that decision to the SBE.

Subject: Approval for Temporary Waiver from High School Graduation Requirements

Background

The temporary waiver from high school graduation requirements allows a public school, private school, or community college to delay implementation of the 24-credit graduation requirements in WAC 180-51-068. For community colleges, this allows alignment of high school completion programs to service district partners. By utilizing this waiver, students will need to meet the requirements of WAC 180-51-067 that include Algebra II rather than the requirements of WAC 180-51-068. Accessing the waiver will allow colleges to grant diplomas to the Classes of 2019 and 2020 based on the lower 20 credit requirements, as opposed the enhanced 24 credit requirements. This could assist students to complete their secondary credential and transition to college and career.

Recommended Action

It is the recommendation of the administration for the Board of Trustees to approve the proposed waiver.


